

Report on the Status of the Building Project and Continuity of the Temple

1. On May 6, 2023, the application for the approval of the building was submitted, electronically, to the City of Johannesburg.
2. On May 16, 2023, the City of Johannesburg invoiced the temple for the building plan processing fees. The amount of R11 684.00 was paid electronically.
3. On June 5, 2023, the City of Johannesburg advised that the application is now on "verification phase" stage.
4. The Committee is on standby for further communications from the City of Johannesburg. Regular updates are posted on the electronic platform.
5. BALALALAYAM. The date of the de-energization of the temple and the re-energization of the temporary temple will be made once the plans are approved and communicated to all devotees.
6. The preparatory work to establish a temporary temple, to be construed in a prefabricated building, is in progress.
7. The Board resolved that our temporary temple would stay open for prayer and worship during the construction period. Our Gurus will be available for prayer and consultations on a daily basis as per normal temple operating, hours seven days a week.
8. All the prayers as per our Melrose Temple calendar will be observed for the public, albeit on a smaller scale. Notifications of these prayer observances will be communicated via our normal media channels to our devotees.
9. Regular Sunday Service, from 10:00 to 11:00, will continue throughout the construction period.
